- i. Central Office Al Quimby asked about the progress on the Interstate 80 interchange to I-99 project at a previous meeting. Carey followed up on that question by stating that the project went out for construction last year and should be finishing up. Larry Schieffelin promised to take a look at some of the roads in the region, and scheduled a Ride Along on may 10th to do so. Eric High is the new district executive for District 3.0. The PennDOT Program Center started an initiative last year to conduct a planning process review, and the project review of the Northern Tier RPO is scheduled for next winter.

- **iii. District 4.0** Attended a meeting last Wednesday, March 30th, with New Milford Borough to discuss options at the Route 11 & 492 intersection. - i. Bradford County Bradford County's FEMA Project, County Bridge 21, should have a new deck poured tomorrow, April 5th, if weather permitting. The bridge should be reopened in May, which will close out on all flood damage projects in Bradford County from 2018. Bridge 38 is nearing NEPPA clearance and can move into final design. Bradford County is investigating 8 other bridge projects to ensure that they do not fall into the "poor" condition category.
