### I. Items for Discussion

### C. Performance Measures PM1, PM2 & PM3 Target Setting Approval

#### **D. PennDOT Connects Update**

### E. Redundant Bridge Study

As stated in the last meeting, Northern Tier is working with Central Office, District 3 and 4, and WATS MPO to put together a study to determine redundant bridges in the region. Mark Murawski is currently putting together a scope of work. Carey stated that they are trying to find available funding before moving forward.

### F. Public Participation Plan update

Northern Tier sent out a poll to set up a date for the Public Participation Plan meeting. The meeting is scheduled for March 10<sup>th</sup>. The meeting will consist of recommendations from PennDOT and FHWA for the update of the PPP.

### G. Annual Obligated Report

Northern Tier put together the Annual Obligated Report, which is a listing of Obligated Projects for which Federal Funds have been obligated in FFY 2020, October 1, 2019 – September 30, 2020. This report was due at the end of December. Northern Tier sent out a copy of the report and a link to view it on the website to RTAC members.

### H. Multimodal Applications

There were two applications that needed to be reviewed by Northern Tier: Marsh Creek Greenway and Tunkhannock Mobility Study. Brian stated that he and Katie just received access to the applications and they will be going through a tutorial tomorrow.

### I. PennDOT Pathways

Due to shrinking gas tax and federal revenues, PennDOT released a program called PennDOT Pathways. This focus allows for more funding source opportunities in the future. In the current phase of the Pathways program, the focus is on highway and bridge funding needs. An email will be sent out with the website information.

### J. Act 106 (Personal Delivery Devices)

On November 1, 2020, Senate Bill 1199 (Personal Delivery Devices) was enacted and will go into effect on January 30, 2021. A PDD is a ground-based delivery device that is manufactured for transporting cargo or goods and is operated by a driving system that allows for autonomous and/or remote operations. PennDOT needs input on PDD's to establish policies. Some questions that were brought up are should they be treated as pedestrians, what are the security risks, who has the right of way? Any questions or suggestion should be sent to Brian or Katie.
