Chris Hume, owner of Hume's Garden Center, received a loan through NTRPDC and Develop Tioga to open a new garden center in Tioga County, PA. Hume's Garden Center will be a locally owned

and operated garden center and cafe located centrally on Route 6 between Wellsboro and Mansfield. This location will include a greenhouse and retail garden center operation, offering trees, shrubs, annuals, perennials and fresh produce. The building will also contain a café serving fresh food options, specialty coffee, and hand-dipped ice cream.

Hume's Landscape Service has operated in and around Tioga County, PA since 1978. Chris Hume has worked in the family business since he was 13 years old, and has spent his life learning the business, studying plants, building relationships with his customers, and perfecting his design and installation skills. This foundation makes the garden center a natural extension of the existing landscape business.

Owners of Pine Creek Wilds Co., Kim & Rob Neyhard, are developing and opening a family owned and operated ebike rental & camp store to be located at 5426 Route 6 Wellsboro, PA 16901.



This new business is located on a busy main thru-way to Colton Point State Park and has easy access to the Pine Creek Rail Trail and the PA Grand Canyon, which allows customers to have a variety of bike route options. Use the rail trail to enjoy a trip into the town of Wellsboro for shopping and entertainment, travel to Blackwell for an outdoor adventure, or to Colton Point State Park for spectacular overlooks of the canyon. The property is also in close proximity to popular fishing creeks including; Pine Creek, Marsh Creek, and Asaph Run making it a common fishing area for tourist, campers, and locals alike.

Registered Apprenticeship and Pre-Apprenticeship

Ongoing Acceptance of ARC Pre-Applications



We are delighted to announce the ongoing acceptance of pre-applications on a rolling basis for the 2023-2024

<u>Appalachian Regional Commission (ARC)</u> grant funding round.

Funding through the program is a federal (ARC), state (PA DCED) and local (NTRPDC) partnership.

As the designated Local Development District for the Appalachian Regional Commission (ARC), we are excited to provide you with information related to the ARC **Area Development** and ARC **Local Access Road** Programs.

Most of the pre-applications will be considered for funding in the Summer/Fall of 2024.

ARC Grant Quick Facts:

How much can be requested?

- Area Development Grants range from \$30,000 to \$750,000
- Local Access Road Grants range between \$500k-\$1M

Do ARC grants require a match?

- Area Development Grants require 1-to-1 federal to state/local match.
 Match can include cash, in-kind, and other secured funding sources.
 EDA, USDA, and a few other federal funding programs can be used for up to 80% of the match.
- Local Access Road Grants do not require match, but match is highly recommended to remain competitive.

How do I apply?

- Contact NTRPDC to determine eligibility before submitting a preapplication as some of the priorities have changed at ARC and PA DCED.
- A copy of the required ARC pre-application (two-pages or less) should be submitted to Katie Smith. We provide individual templates for both the Area Development and the Local Access Road Program. Additional information may be required once the pre-application is reviewed by NTRPDC staff.

DCED Local Share Account (LSA) Application Period Opening in September



The PA Race Horse Development and Gaming Act (Act 2004-71), as amended, provides for the distribution of gaming revenues through the Commonwealth Financing Authority (CFA) to support projects in the public interest within the Commonwealth of Pennsylvania.

Applications will be accepted from September 1st, 2023 to November 30th, 2023.

Elligible projects include:

- Projects in the public interest.
- Projects that improve the quality of life of citizens in the community.
- Eligible projects must be owned and maintained by an eligible applicant or a nonprofit organization.

Eligible applicants include:

- Pennsylvania Counties
- Municipalities
- Municipal Authorities
- Economic Development Agencies
- Redevelopment Authorities

Funding

- Grants are available for projects with a total eligible project cost of \$25,000 or more. Grant requests shall not exceed \$1,000,000.
- No match required.

Senator Bob Casey Announces EDA Recompete Pilot Program

EDA's Recompete Pilot Program is a new program authorized by the CHIPS and Science Act that will invest \$200 million in persistently distressed communities to create and connect people to good jobs.

The Recompete Pilot Program will provide flexible funding to communities that can be used for a variety of activities to promote economic development and is available to areas where the prime-age employment (25-54 years) significantly trails the national average (an updated eligibility map is available **here**, and the Notice of Funding Opportunity is available **here**).
